Dear Secretary Rubio:

We are writing to urge you to reverse recent actions taken by the Trump Administration to eliminate the United States Agency for International Development (USAID). These actions were executed without the requisite Congressional consultation and are unconstitutional. They include placing the entire USAID direct hire workforce globally on indefinite administrative leave, terminating all "non-essential" Institutional Support and Personal Service Contractors, and instituting stop work orders.

The Congressional Caucus on Global Migration and other concerned Members of Congress, know these actions will drive forced and irregular migration worldwide by reducing access to humanitarian aid, hindering economic opportunity, increasing violence, and strengthening the likelihood of disease and famine.

USAID's humanitarian and development programs, when executed in solidarity with the local communities, can play a role in addressing the conditions across the globe that enable people to build the life they want and deserve *at home*. *USAID* operations specifically designed to invest in humanitarian aid can help alleviate crises before they generate mass migration movements. For example:

- One 2019 study found that in Guatemala, participants in an agricultural support program saw a **30 percent drop** in young people considering migration.^[1] These programs are now at risk, further destabilizing the region.
- USAID programs designed to address hunger can reduce the prevalence of famine. Approximately 4.5 million children under the age of five are facing acute malnutrition in the Democratic Republic of Congo. Title II Food Aid, administered by USAID, utilizes the Family Early Warning Systems Network. This vital network enables the U.S. to identify potential famine, preventing acute food insecurity from becoming a destabilizing event that drives conflict and migration.
- Some USAID-funded security programs have been essential in reducing violence in major migrant-producing countries. [3],[4] In Colombia's Norte de Santander, funding freezes have left authorities without resources to combat rising violence and manage the influx of Venezuelan refugees. [3] Without these programs, criminal recruitment will rise, disproportionately affecting women and children. [3]
- USAID programs also support current host countries to provide protection, legal status, and opportunities to integrate/settle successfully. Similarly, a U.S.-funded initiative in Ecuador aimed at regularizing **100,000 Venezuelans** is now in jeopardy. [3],[5] Without this

support, fewer Venezuelans will be able to integrate locally, increasing the likelihood of onward migration through irregular routes.^[3]

• Finally, USAID programs play a crucial role in monitoring and preventing the spread of diseases. USAID plays a vital role in controlling HIV/AIDs epidemics, and preventing infectious diseases, such as Ebola, Measles, and Polio. Former USAID employees have warned that the dismantlement of USAID has increased the risk of potential pandemics, specifically Mpox and Ebola. The Agency's work in prevention, preparedness, and rapid response to disease outbreak has been significantly impacted [6]; this threat poses a risk to both the global community and our domestic biosecurity and will result in the loss of lives. [7]

Your Administration has expressed a commitment to reducing irregular migration. Your actions run counter to this commitment and exacerbate the conditions on the ground that drive people to be on the move. We believe that improvements can be made to USAID that make it more community-led, judicious in its partnerships, and more responsive to local conditions. We urge you to immediately halt the stop-work orders and restore USAID's operational capacity.
